



# Transportation of thermolabile shipments

### Transportation temperature regimes:

from +15 to +25 °C from +2 to +8 °C from -15 to -25 °C Deep freeze

  with the provision of validated insulated shippers
  and thermoelements of our own production.
- ✓ Transportation of deep frozen products is carried out with the provision of validated insulated shippers with dry ice provided by reliable supplier
- ✓ Order of validated vehicle-refrigerator. Service "Vehicle order from door to door"
- ✓ Temperature monitoring throughout the transport by calibrated temperature loggers, which comply with GxP and 21 CFR Part 11 и EN 12830 demands. Readings of loggers are available at personal Client account 24/7

## Insulated shippers for medicinal use

5 types of insulated shippers are used to ship thermolabile drugs and materials::

- ✓ GDP 4L
- ✓ GDP 9L
- √ GDP- 20L
- √ GDP- 43L
- √ GDP- 68L

All insulated shippers are made of rigid polyurethane foam and polyvinyl chloride which ensures the integrity and reliability of thermal equipment during transportation.

Insulated shippers are additionally equipped with a bag-cover made of moisture-proof polyester or a corrugated box.

#### Applicable thermoelements:

white color –temperature +15...+25°C blue color - temperature +2...+8°C red color - temperature -15...-25°C



Temperature equipment and configuration is validated in accordance with international standards at regular intervals. The fundamental criteria during validation are the standards of the International Safe Transportation Association - ISTA (USA), as well as the use of additional stress tests (artificial creation of critical conditions) to provide a 100% guarantee of proper transportation.
